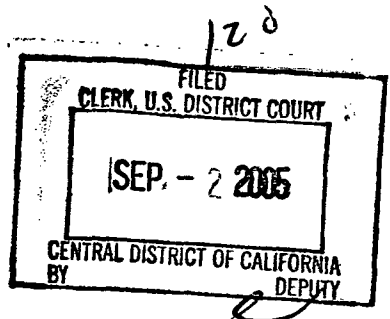

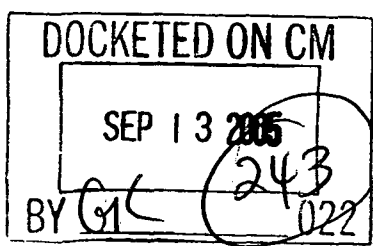

**DECLARATION OF
MICHAEL ROSENBAUM IN
SUPPORT OF APPLICATION FOR
AN ORDER AUTHORIZING
DISTRIBUTION OF NET
SETTLEMENT FUND**



1 I, MICHAEL ROSENBAUM, declare:

2 1. I am over 21 years of age and am not a party to this action. I have personal
3 knowledge of the facts set forth herein and, if called as a witness, could and would
4 testify competently thereto. I submit this declaration in order to provide the Court
5 and the parties to the above-captioned action with information regarding the
6 administration and processing of proofs of claim in connection with this action.

7 2. I am Managing Director of Berdon Claims Administration LLC ("Berdon"),
8 Claims Administrator for the above-captioned action. I am and have been the person
9 at Berdon primarily responsible for administering the settlement and have worked
10 with and under the direction of Settlement Class Counsel ("Counsel") in effecting the
11 claims administration process regarding this matter.

12 3. I make this declaration in support of Plaintiffs' application for an Order
13 authorizing the distribution of the Net Settlement Fund, to describe the claims
14 administration process that Berdon has provided in this matter, and to request that the
15 Court approve the payment of Berdon's fees and expenses in the total amount of
16 \$381,011.14.

17 4. Berdon was appointed Claims Administrator to arrange for the printing and
18 mailing of the Notice of Proposed Settlement of Class Action, and Proof of Claim
19 (the "Notice"), to arrange for publication of the Court-Ordered Legal Notice (the
20 "Summary Notice"), to maintain a file in connection with requests for exclusion, to
21 submit periodic reports to Counsel in connection therewith, and to administer the
22 processing of Proof of Claim forms ("Proof(s) of Claim," "claim form(s)") and the
23 distribution of the Net Settlement Fund to all persons who, during the period of
24 February 15, 1998 through May 2, 2003, had a valid agreement of distributorship
25 with Herbalife International, Inc. and Herbalife International of America, Inc.
26 ("Herbalife") to sell Herbalife products as independent distributors, had attained the
27 level of Supervisor, who purchased Newest Way to Wealth ("NWTW") materials or
28 devices ("Settlement Class Members") and who filed valid Proofs of Claim.

1 5. Berdon was primarily responsible for arranging the printing and mailing of
2 the Notice to Settlement Class Members, on July 15, 2004. Berdon was also
3 primarily responsible for the publication of the Summary Notice in *USA Today* on
4 July 22, 2004.

5 6. In performing these tasks on behalf of Counsel, this office dealt directly
6 with a financial printer with regard to the Notice, and with an advertising agency in
7 connection with the Summary Notice, made formatting suggestions to counsel, and
8 compiled counsel's comments on the galley proofs of the Notice and Summary
9 Notice. In addition, Berdon prepared mailing labels for Settlement Class Members
10 from the names and addresses in a data file furnished to us by the Defendants and
11 from the names and addresses provided to this office by one of the Counsel. These
12 labels were utilized in the initial mailing of the Notice on July 15, 2004, and
13 subsequently, up to and including June 16, 2005, the Notice was also mailed to 84
14 other Settlement Class Members and potential Settlement Class Members who
15 contacted Berdon to request copies thereof.

16 7. Pursuant to instructions from Counsel, Berdon created a separate letter, into
17 which was merged the purchase/commissions information furnished in the Defen-
18 dants' data file, and mailed concurrently with the Notice to those identified by the
19 data file as Former Supervisors. Those Former Supervisors who did not retain all the
20 documentation necessary to determine their income and expenses as part of the
21 Method A claim calculation were able to file their claims under the Method B option.
22 Berdon has reviewed and analyzed, individually and in great detail, all the claim
23 forms received from potential Settlement Class Members. We have also answered
24 any questions regarding the action, the Settlement and procedures for filling out the
25 Proof of Claim and were in contact with Counsel to review the status of the claims
26 administration process and to address concerns regarding claims that Berdon had
27 deemed either questionable or problematic. Our final report (the "Summary of the
28

1 Claims Administration Process"), which is described in detail below, is annexed
2 hereto as **Schedule 1**.

3 8. In reviewing the 2,701 Proofs of Claim submitted, Berdon determined that
4 some were deficient or incomplete. Among the various types of deficiencies found
5 were: (a) claim forms were not filled out completely; (b) the information provided
6 was either insufficient or discrepant; (c) claim forms were not signed by the proper
7 party, or at all; (d) claimants did not provide documentary proof of their supervisory
8 status; or (e) claimants had failed to submit adequate documentation of their business
9 expenses and income, purchases of NWTW materials, or otherwise failed to give
10 adequate information thereof. Berdon mailed letters to these Claimants (**Exhibit A**),
11 advising them of the deficiencies identified in their filings and requesting additional
12 information and/or documentation, and they were given at least 20 days to do so. On
13 our website, we provided guidelines designed to assist claimants in preparation of
14 their responses to these letters. In many cases, the deficiencies were cured. If they
15 were not cured, Berdon mailed final notices to these claimants (**Exhibit B**) and made
16 follow-up telephone calls where further clarification was required.

17 9. Berdon's Summary of the Claims Administration Process (**Schedule 1**) sets
18 forth the final status of claims received by this office, detailed as follows:

19 a. **Properly Completed Claims:** Berdon has identified 2,653 properly
20 completed claim forms. Included in this category are 172 Current Supervisors
21 (**Exhibit C**) and 2,481 Former Supervisors. Former Supervisors claimed
22 \$19,731,186.11 in Economic Losses and \$7,557,576.92 in Refund Pool Claims
23 (**Exhibit D**). We reviewed the available supporting documentation. Nothing has come
24 to our attention that would indicate any material discrepancy.

25 Among the properly documented claims there are 2,574 claims that were
26 filed timely and 79 claims received after the filing deadline. Late claims have been
27 included, since it appears that these claimants did not learn about this action until
28

1 after October 26, 2004. We recommend that all valid and complete claims be
2 approved as rendered by the exhibits.

3 Each Authorized Claimant's claim was calculated in accordance with the
4 appropriate method of calculation and based upon the guidelines and formulas
5 outlined in the Notice.

6 **b. Claims Not Documented:** Berdon has identified 13 inadequately
7 documented or completely undocumented claim forms. Included in this category is
8 1 Current Supervisor (**Exhibit E**) and 12 Former Supervisors. We estimated damages
9 for the Former Supervisors at \$27,605.25 in Economic Losses and \$28,999.09 in
10 Refund Pool Claims (**Exhibit F**), and we recommend that these claims be rejected
11 As stated above, we have communicated with these Claimants and advised them of
12 our determination. None has objected to or contested this determination.

13 **c. Ineligible Claims:** Berdon has identified 35 claims which we also
14 recommend for rejection (**Exhibit G**). Included in this category are: (i) claims from
15 individuals who were not Herbalife Supervisors during the Class Period; and (ii)
16 duplicate claims. All of these Settlement Class Members have been notified (**Exhibit**
17 **H**), and none has objected to or contested this determination.

18 10. Berdon has charged a fee in the total amount of \$375,000.00, as set forth in
19 our invoice (**Exhibit I**). The fee covers a variety of services, including, but not
20 limited to: (a) creating data bases and computer programming services; (b) arranging
21 for the printing of the Notice and publication of the Summary Notice; (c) creating
22 mailing labels for the initial mailing of the Notice; (d) creating and mailing a separate
23 letter to Former supervisors; (e) fulfilling all subsequent requests from Settlement
24 Class Members for copies of the Notice; (f) reviewing and analyzing claims; (g)
25 providing telephone and e-mail assistance to claimants; (h) calculating the damages
26 for ultimate distribution of the Net Settlement Fund to claimants; (i) preparing all
27 required reports and declarations; (j) preparing and mailing settlement checks to
28

1 claimants; (k) preparing income tax returns; and (l) any and all future services to be
2 rendered, all detailed in **Exhibit I**.

3 11. During the course of the administration of this matter, and up to and
4 including August 11, 2004, Berdon incurred out-of-pocket expenses in the sum of
5 \$44,975.39 which have already been paid. However, since that date, this office has
6 incurred and will incur the expenses included in **Exhibit I** in the total sum of
7 \$6,011.14.

8 12. Therefore, I respectfully request that Berdon's outstanding fees and
9 expenses in the aggregate amount of \$381,011.14 be approved for payment out of the
10 Net Settlement Fund.

11 I declare under penalty of perjury that the foregoing is true to the best of my
12 knowledge and that this declaration was executed this 23rd day of August, 2005 at
13 Jericho, New York.

FOR PROFESSIONAL SERVICES RENDERED AND TO BE RENDERED in connection with the notice and administration of the Herbalife-NWTW Litigation ("Herbalife") and out-of-pocket expenses from August 12, 2004 to date and continuing, excluding all expenses already paid:

Our class action support staff included the Berdon Claims Administration LLC ("Berdon") Managing Director, managers, supervisors and claims administrators, as well as computer programming support, data entry, telephone customer service and file retrieval personnel. Staff members were involved on an ongoing basis with all matters relative to the Notice of Proposed Settlement of Class Action and Proof of Claim (collectively, the "Notice") in connection with Herbalife, as follows:

Reviewed the Preliminary Approval Order to coordinate the Court-ordered time schedule with the necessary procedures for initial mailing and other deadlines.

Converted into mailing labels the names and addresses of potential Settlement Class Members identified: (a) from the data file furnished to Berdon by defendants, and (b) from a list provided to Berdon by one of the Settlement Class Counsel ("Counsel"); corresponded by e-mail with Settlement Class Members to ascertain their postal addresses where only e-mail addresses had been furnished; and arranged for Berdon's Printer to globally search the combined mailing list to eliminate duplicate records.

At the request of Counsel, reviewed and analyzed drafts of the Notice, made suggestions for changes and/or additions to the language and layout, and prepared a 3-page memo for Counsel that memorialized the comments resulting from said analysis.

Arranged for the input and various revisions of galley proofs of the Notice, reviewed same, made further suggestions to Counsel regarding format and layout, integrated all changes and comments, and obtained final approval of revised proofs; calculated the size of the print run, and arranged for the printing and July 15, 2004 mailing of 8,772 copies of the Notice.

Subsequent to the initial mailing, and upon receipt of mailed, e-mailed, faxed and telephoned requests, an additional 84 Notices were mailed to potential Settlement Class Members who had failed to receive one.

Upon instructions from Counsel, Berdon created a letter into which this office merged the purchase/bonus information that had been furnished by the defendants, and the letter was mailed concurrently with the Notice to 7,779 potential Settlement Class Members who had been identified in the data file as "Former Supervisors."

In consultation with Counsel, assisted in the preparation and, after final approval, arranged for the publication, of the Summary Notice, which appeared on July 28, 2004 in *USA Today*.

Established a post-office box and provided for daily pick-ups of mail, which were then sorted into: (1) returned mail; (2) requests for copies of the Notice; (3) completed claim forms; and (4) requests for exclusion.

Maintained an "800" customer service telephone number during normal business hours, enabling Berdon's customer service staff and/or claims administrators to respond to: (1) requests for copies of the Notice; and (2) questions and concerns from potential Settlement Class Members with regard to: (a) the language in the Notice and/or the letter to Former Supervisors; (b) the completion of the claim form; (c) the appropriate documentation to be submitted; (d) the status of a particular claim; and (e) the current settlement, generally.

Kept a daily log of all incoming requests for the Notice and the dates of compliance therewith.

Re-addressed and re-mailed approximately 500 returned Notices where a forwarding address was provided, and answered all general correspondence.

Received and kept a record of requests for exclusion and provided photocopies thereof to Counsel.

Prepared a Declaration in connection with: (1) the date and size of the initial Notice mailing, (2) the date and size of mailing of the letter to Former Supervisors, (3) the fulfillment of requests for copies of the Notice, (4) the publication of the Summary Notice, and (5) the number of exclusion requests received, which was submitted to Counsel for filing with the Court.

The claims administration procedure utilized was as follows:

Opened all submissions upon receipt, assigned a claim number to each claim form, and filed each claim in a folder bearing a corresponding number.

Examined all claims submitted by potential Settlement Class Members to determine their eligibility, category (Current or Former Supervisor), benefits claims and losses incurred while in the distributorship program.

Created and utilized two database systems, one containing the data provided by the defendants and one compiled from the information received from potential Settlement Class Members, which were programmed to work together, thereby making the entire process more efficient by minimizing the amount of data entry and unnecessary data verification.

For those in the Current Supervisor category, it was necessary to confirm claimants' supervisory status and verify purchases of NWTW items, by referring either to the records received from the defendants or by examining the supporting documentation furnished by claimants.

For those in the Former Supervisor category, it was necessary to confirm claimants' supervisory status, verify purchases of NWTW items and establish the extent of the losses incurred by each while in the distributorship program.

Claimants in the Former Supervisor category had two options to claim damages: Method A, a self-prepared schedule of expenses, income, economic losses and purchases of NWTW items, enumerated separately; or Method B, a pre-determined summary of economic losses and purchases of NWTW items. In processing claims where Method A was utilized, administrators had to identify, assess the eligibility of, categorize, verify and summarize various receipts, statements and tax documents describing the business transactions made by these claimants over the period of 3.5 years, on average, that was directly associated with the distributorship program. Unfortunately, although the most obvious type of supporting documentation was Schedule C of the individual's federal income tax return, it was inadequate in most cases due to its cumulative presentation of various unrelated business activities and, in most instances, administrators had to evaluate the extent of damages by examining individual receipts, cancelled checks, credit/debit card statements and related bank statements.

Identified various items claimed by Former Supervisors that were either ineligible or not relevant to the computation of compensatory

damages in this case, and our findings were communicated by letter to these claimants.

Created drafts of deficiency notices, rejection notices, etc., submitted same for approval of Counsel and communicated our findings to the claimants. As a result, additional documentation was received, or agreements were reached to accept the amounts determined by the administrators and supported by the documentation. In each instance, vigorous efforts were made to ensure that the extent of damages was verified and that they represented, as closely as possible, the losses incurred by Settlement Class Members.

The unique characteristics of this case and the specificity of the problems encountered during the examination of claims required the administrators to spend a substantial amount of time communicating with claimants by telephone regarding the deficiencies in their claims. In addition, e-mail correspondence and customized letters were utilized to expedite matters and make the claims administration process as efficient as possible.

Created online presentations designed to give claimants a better understanding of the process, which resulted in the improved quality of responses to deficiency notices.

At the beginning of the claims process, defendants' counsel requested Berdon to estimate the number of Current Supervisors who might file claims in order for them to ascertain Herbalife's potential liability, and a range was provided of the probable number, together with a list of those Current Supervisors who had already filed a claim.

Performed computer searches by name, address and Herbalife identification number to identify, compare and eliminate any duplicate claims and claims filed by individuals not identified by the defendants as either Current or Former Supervisors.

Provided Counsel with reports as to: (1) the status of completion and (2) certain claims processing assumptions that would be made; and discussed with Counsel certain aspects of the Plan of Allocation and the data provided by defendants.

Prepared final reports for Counsel and a final declaration for the Court in connection with claims processing procedures, the total claims to be recommended as eligible and complete and those for which rejection is to be recommended, as well as the calculation of Economic Losses, Refund Pool damages and the proposed distribution.

Prepared a report setting forth the damages for each valid claimant and the aggregate damages for all valid claimants, as well as a report setting forth each valid claimant's share of the distribution.

Prepared and filed Settlement Fund income tax returns for the tax year 2004 and will do so for the tax year 2005, when required.

Upon receiving Court approval, this office will order, prepare and mail distribution checks to all eligible claimants.

In the normal course of events, Berdon will replace lost or stolen checks and reconcile bank statements and outstanding checks. We will trace those claimants whose checks do not clear and attempt to contact them to effect clearance of their distribution checks.

All records in connection with this matter will be maintained for a period of three years, or such other period as may be required.

There have been 3,629.40 hours of services rendered and approximately 100 hours are anticipated to be rendered to completion, including the preparation of all necessary tax returns.
